Bus Rental Agreement

Our bus is a 2013 StarCraft that seats 13 guests plus 1 in the passenger seat.

Please follow these simple rules while on the bus and listen to the driver if given instructions

- Enter at your own risk. Guests are responsible for their own safety. We are not responsible or liable if any guest gets injured while on the bus. The signer of this contract is responsible for their guests and their behavior.
- No fighting allowed on the bus.
- Do not distract the driver or harass the driver. We want everyone to always be safe and courteous.
- No standing or sitting on the back of the seats.
- While the bus is in motion, passengers are encouraged to sit with their seat belt on.
- No smoking (\$250 minimum) cleanup fee will be imposed and no illegal drugs allowed on the bus.
- We are not responsible for lost, damaged or stolen items. The driver will watch over the bus.
- Guests are welcome to bring their own beverages while riding the bus but may not carry open containers of alcohol onto or off the bus. **No glass bottles please**
- No underage drinking (if someone is on the bus that is underage, no alcohol is permitted) – the driver has the right to card anyone they feel is underage.
- If you spill something, please clean it up right away.
- If you wish to bring food, please do not have foods that will leave odors or stains.
- No glitter, confetti or anything that will make a mess on the bus.
- Your event starts when we arrive at the pickup location and ends when the last person exits.
- If we are pulled over because of passenger misbehavior the evening will come to an end and the full amount will be due.
- Violations of any of the above could result in the immediate termination of the agreement with full payment due.

DEPOSIT, PAYMENT & GRATUITY

A refundable deposit of \$250 is required to hold your date and serve as your security deposit for any damage. The deposit check is separate from the rental payment and gratuity and will be returned if the contract is followed. Please make the check to Michael Cummins and mail it to 7727 Sod Road, Brook Park, MN 55007.

Our driver will work hard for you. We encourage you to give the driver 20% at the end of the night for their excellent service.

Full payment is due at the time of pickup. The full payment can be made in cash or PayPal.

DAMAGE POLICY & FEES

The driver inspects the bus before, during and after each rental. In the event of damage, the client will be responsible for any repairs, cleaning and loss of income from the bus being put out of service during repairs.

There is a \$150 fee for a body fluid spill on the bus or unusual clean up after the event. There will be a garbage can with a liner when picked up.
